 - **Produce picked up within 48 hours**
 - **All other orders picked up within 72 hours**
- **GreenTree reserves the right to specify pick-up times dependent upon size of the order.**
- **Failing to follow above timelines will result in loss of product with full payment billing.**
- **GreenTree reserves the right to terminate this agreement at any time.**

Our open account terms of sale are Net 15 days. A late payment charge of 1.5% per month will accrue on all past due accounts. In the event that any account is referred by GreenTree Cooperative Grocery to a collection agency, attorney, or other individual or entity serving in that capacity, and thereafter the account is paid, the applicant agrees that the applicant will pay, in addition to the balance of the account, an amount equal to the reasonable collection fee charged GreenTree Cooperative Grocery by the collecting entity, attorney or individual, or adjudged by the court as reasonable attorney's fees and costs to be allowed the plaintiff in suit or action, and, if an appellate court shall adjudge reasonable attorney's fees and costs on such appeal.
