



## A Statement of Rights of and Restrictions on Ownership at GreenTree Co-op Market:

*Per Michigan law, and prior to becoming a Member/Owner, GreenTree is required to advise each prospective Owner of the following rights and restrictions on Ownership and Owner capital. Please review this and sign at the bottom to signify your understanding.*

1. GreenTree Co-op Market is subject to the Michigan Nonprofit Corporation Act, as amended (P.A. 162 of 1982; M.C.L.A. 450.2101 et seq.). GreenTree Co-op is organized under the Consumer Cooperative Act, which is Chapter 11 of the Michigan Nonprofit Corporation Act, as amended.
2. The purpose of Member/Ownership in GreenTree Co-op Market is to assure access to the goods, services, and facilities of the cooperative, not to gain profit.
3. Member/Owners are entitled to receive notice of and to attend special meetings and vote on issues put before the Member/Ownership as stated in Article III (Sections 3.1, 3.2, 3.4, 3.5, 3.6) of the Bylaws\*.
4. Member/Ownership in GreenTree is open to all regardless of race, color, sex, religion, national origin, sexual orientation, gender identity or expression, or disability. A requirement of Member/Ownership in GreenTree is payment of Member/Owner capital in an amount determined by the Board of Directors. For more information, please reference Article II (Section 2.1, 2.2, 2.3) of the Bylaws\*.
5. Member/Ownership in GreenTree may be terminated by death, resignation, failure to pay Owner capital, or decision of the Board of Directors. Upon termination of Ownership, member capital will be redeemed within 5 years. For more information, reference Article II (Section 2.4) of the Bylaws\*.
6. An Owner's membership and the Owner capital paid by an Owner belongs to the Primary Signing Shareholder and is neither transferable nor assignable.
7. Owners have the right to call special meetings and cause referenda on issues of concern to them. These rights are covered in Article III (Section 3.2) of the Bylaws\*.
8. Owners have the right to receive Annual Reports and secure other material information. For more information, reference Article III (Section 3.1) of the Bylaws\*.
